## Abstract

The 2RT0435T is a Base Board based on the SCALE<sup>™</sup>-2 driver core 2SC0435T designed to drive almost all available 1200V IGBT modules like 62mm IGBT modules, 130mm x 140mm IGBT modules and others. The Base Board features an electrical interface with a built-in DC/DC power supply. This Base Board is a two layer solution, assembled exclusive with THT-components.

The turn-on and turn-off gate resistors of both channels are not assembled in order to provide maximum flexibility. They must be assembled by the user before start of operation. Please refer to "Description & Application Manual for 2RT0435T Base Boards" for more information.
